#### **Purpose of report**

1. To provide information for Council to vote to either retain or disestablish the Marlborough Māori Ward in accordance with the Local Government (Electoral Legislation and Māori Wards and Māori Constituencies) Amendment Act 2024.

#### **Executive Summary**

- 2. Council can either vote to retain or disestablish the Marlborough Māori Ward.
- 3. If Council votes to retain the Marlborough Māori Ward, Council must resolve to hold a binding poll on the Marlborough Māori Ward at the 2025 Local Election.
- 4. If Council votes to disestablish the Marlborough Māori Ward, Council must undertake a shortened representation review process immediately to meet the required deadline outlined in the Local Government (Electoral Legislation and Māori Wards and Māori Constituencies) Amendment Act 2024.

#### RECOMMENDATIONS

- 1. That Council resolve retain the Marlborough Māori Ward for the 2025 Local Elections and therefore the 2025-2028 Council term; and
- 2. That Council resolve to hold a binding poll on the Marlborough Māori Ward at the 2025 Local Election.

#### **Background/Context**

- 5. The Local Government (Electoral Legislation and Māori Wards and Māori Constituencies) Amendment Act 2024 (Amendment Act) came into force on 31 July 2024. The Amendment Act:
  - reinstates the ability for binding polls on the establishment of Māori wards;
  - provides a transitional poll mechanism for councils that either resolved to establish or established Māori wards since 2020 (without holding a poll); and
  - adjusts key election dates to allow more time for delivering voting papers.
- 6. The Amendment Act's transitional poll mechanism requires Council to resolve to either retain the Marlborough Māori Ward and hold a binding poll at the 2025 local elections or disestablish the Marlborough Māori Ward.
- 7. The Amendment Act further states that Council has until 6 September 2024 to make either resolution.

#### Retaining the Marlborough Māori Ward

- 8. If Council resolves to retain the Marlborough Māori Ward, the Amendment Act states that Council must resolve to hold a binding poll at the 2025 Local Election, with the results taking effect for the 2028 and 2031 Local Elections.
- 9. This means the Marlborough Māori Ward stays in effect for the 2025-2028 Council term.
- 10. Notwithstanding the result of the binding poll on the Marlborough Māori Ward taken at the 2025 Local Election, Council will still need to undertake its regular Representation Review in 2027/28. However, if the result of the binding poll is negative then Council will not be able to consider any Māori Ward until the 2033/34 Representation Review.

#### Disestablishing the Marlborough Māori Ward

- 11. If Council resolves to disestablish the Marlborough Māori Ward (by rescinding the decision made on 21 May 2021), there are two options for the 2025 representation arrangements:
  - complete a shortened representation review process by early April 2025; or
  - revert to their most recent representation arrangements before M\u00e4ori wards were established.
- 12. The shortened representation review must commence immediately with Council to make its initial proposal by 13 September 2024.
- 13. Under the Amendment Act Council cannot consider Māori Wards during this shortened representation review (covers 2025 and 2028 Local Elections). The Amendment Act also states that Council does not have to consider Māori Wards in future representation reviews but can if it chooses to do so.
- 14. Council cannot revert to its most recent representation review as the 2023 population estimates (which must be used) make, not only the Marlborough Sounds Ward, but also the Wairau-Awatere Ward, not comply with the +/- 10% population requirement and as no exception has been granted previously by the Local Government Commission for the Wairau-Awatere Ward then Council must carry out a shortened representation review.

#### Option One (Recommended Option) - Retaining the Marlborough Māori Ward

15. As above.

#### Advantages

- 16. The Marlborough Māori Ward remains for the 2025-2028 term as originally decided by Council at its 2021/22 Representation Review.
- 17. The Binding Poll gives people on the electoral roll the opportunity by simple majority to have their say on whether Council has a Māori Ward for the next two Local Elections (2028 and 2031).

#### Disadvantages

18. The cost of running a poll at the 2025 Local Election is estimated by Council's election provider to be in the vicinity of \$60,000.

#### Option Two - Disestablishing the Marlborough Māori Ward

19. As above.

#### Advantages

20. No poll requirement at the 2025 Local Election.

#### Disadvantages

- 21. Council will be required to undertake a shortened representation review, commencing without delay. Council has not budgeted for this work, neither have staff the resources to undertake this, therefore a contractor will need to be engaged at an unknown cost.
- 22. No Marlborough Māori Ward for the 2025 and 2028 Local Elections.
